Police (Stipendiary Cadet Trainee) Rules, 1999 (Telangana cited under the provisions of 3S. Police (Stipendiary Cadet Trainee) Rules, 1999 (Telangana Adaptation Order, 2015) vide G.O.Ms. No.96 Home (Legal) Department, dated 31-12-2015, and its amendments issued from time to time.

The Selectee should undergo 9 (nine) months Induction Training in the Training Centre allotted to her and she will be paid an amount of Rs 90006. (Ruppecs Nine thousand) per month as Stipend during the training period from the date of commencement of training at the Training Centre. - 8) That he/she shall from the date of joining duty, be on probation for a total period of (2) years on duty within a continuous period of (3) years as prescribed under Rule 9(a) of the Telangana Prohibition & Excise Subordinate Service Rules
- That he/she shall, immediately after appointment, undergo training as may be prescribed.
- 10) That he/she shall, before the commencement of training, execute an agreement on Rs.100 NJS Paper to the effect that he/she shall serve the Department for a period of three years, after completion of training referred to above. - 13) That he/she shall produce Relieving Certificate from the competent authority, if already in service and if he/she is not employed previously, he/she should furnish a solemn affidavit to this effect at the time of reporting for duty.
- 14) That he/she shall be governed by the new Pension Scheme as envisaged in G.O.Ms.No.653, Finance (Pension-I) Dept., dated:22.09.2004 and as aniended from time to time.
- He/she shall wear the pattern of Uniform as prescribed by the Dept.
