

The Anwarul Uloom College of Education, Nampally and Anwarul Uloom College of Elementary Education at Nampally were inspected by the Osmania University and the SCERT respectively. It was advised by the university to appoint a new Principal for the college of education as the incumbant principal will be attaining the age of superannuation by November, 2022. The Anwarul Uloom Collegeof Pharmacy, Mallepily, Hyderabad was inspected by the Pharmacy Council of India and also the Osmania University and no shortcomings were reported. The Anwarul Uloom College of Business Management were extended the recognition by the All India Council For-Technical Education, New Delhi for the year 2022-23. The osmania University too conducted the annual Inspection of these institutions and found them in order and extended affiliation for the year 2022-23.
