3) TERMS OF PAYMENT:

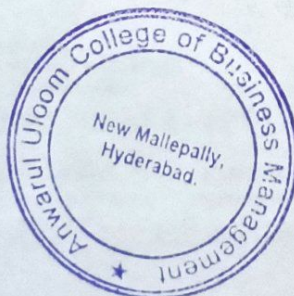
- a) 60% - of the contract value in advance with order.
- b) 30% - of the contract value against delivery of materials before starting the installation works
- c) 5% - after the Installation
- d) 5% - prior to hand over of the Lift for the passenger usage

4) DELIVERY

- a) The Contractor agrees to deliver the materials ex-works, within 3 weeks from the date of signing the agreement, receipt of advance payment and all approvals whichever is later.
- b) When the contractor meets his obligation as per Clause 4 (a) and the client fails to receive the materials under his custody whatever reason, upon client's request and depending on the availability of space, contractor may consider to arrange to store the material at his warehouse or any other location at Client's own risk and expense. Notwithstanding the location of storage, Client agrees to pay to the Contractor, the amount as per Clause 3 (b) or any other amounts due to Contractor for the transfer of materials to any location other than the site, within 30 days from the date of arrival of material.
- c) If the client fails to release the payment within 30 days or by the date agreed between both parties, contractor will dispose off the materials, recover their expenses and pay the balance amount, if any, to the client as final settlement of advance made by him. It is well understood and agreed that any loss consequential to the non-performance of the contract by the client according to this clause shall not be compensated for whatsoever reason

5) INSTALLATION

- a) The contractor agrees to commence the installation of the Lift within 20 days from the date of delivery of material at site and receipt of the Lift shaft at contractor's disposal as per their requirement.
- b) In the event, the contractor is prevented to commence the installation due to the non-availability of the Lift shaft as per their requirement or due to any other reason, then the client agrees to release the payment as per item 3 (c) within 30 days and Item 3 (d) within 180 days from the date of delivery of materials. In the event of long period of storage, the materials shall be inspected and if the materials are to be reconditioned before starting the installation, the re-conditioning works will be done by the contractor for an additional amount and client agrees to pay this additional amount prior to carry out the works.

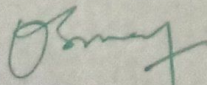

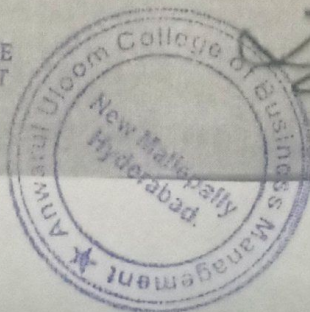

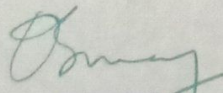
